



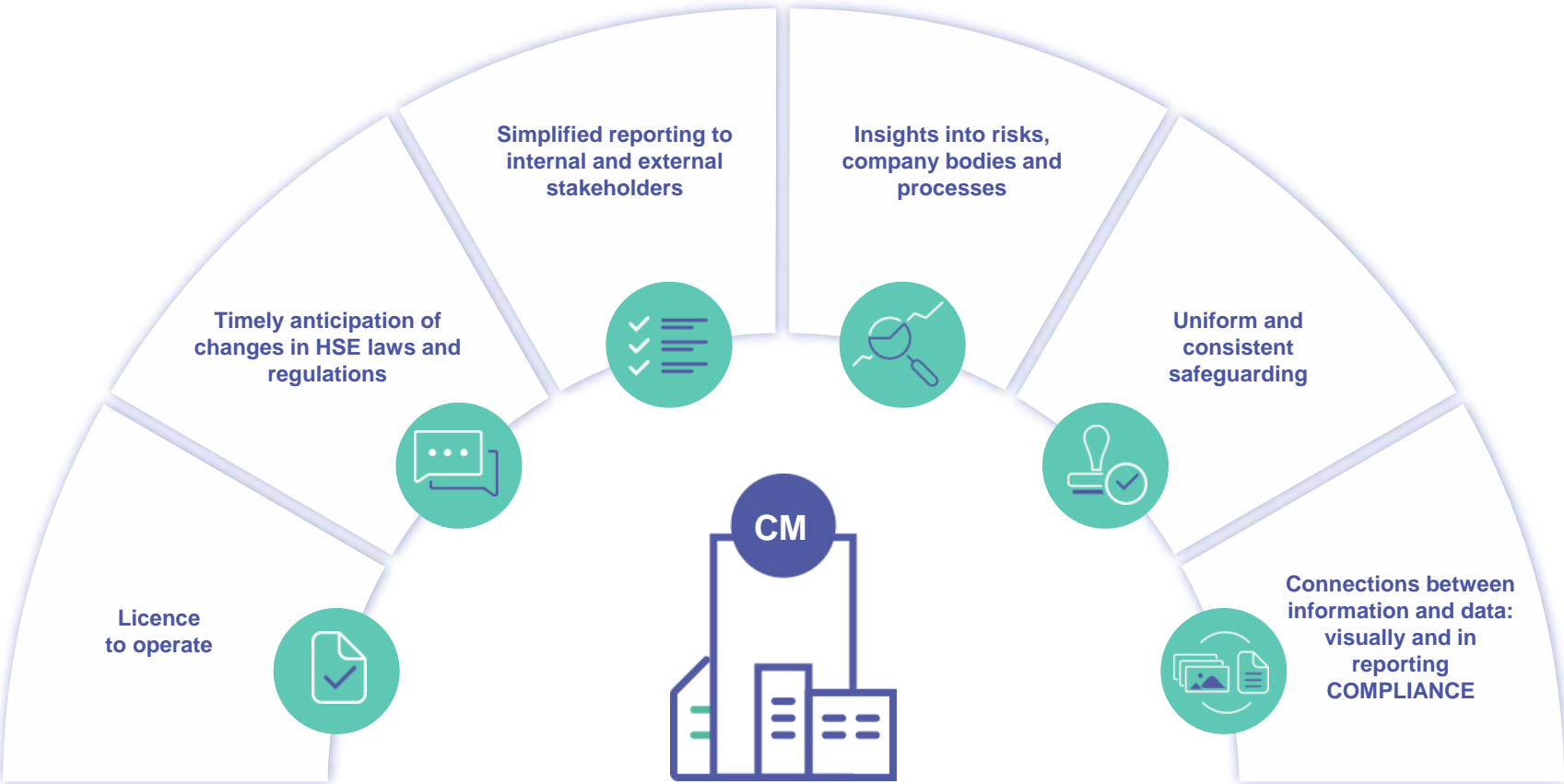

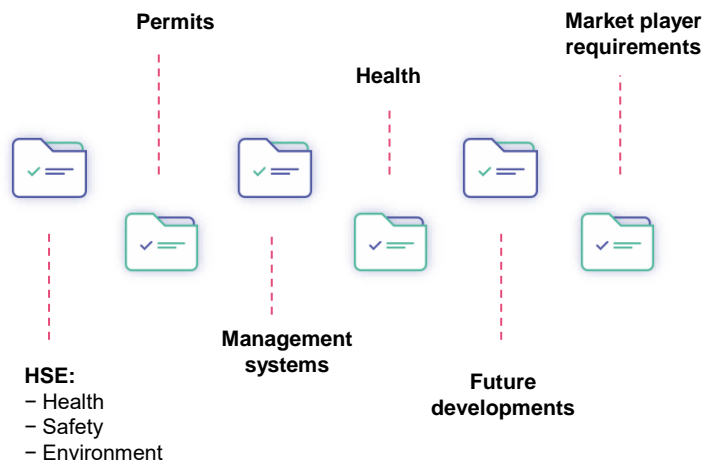
# Compliance Management

An organisation in compliance demonstrably complies with applicable **laws and regulations** and safeguards this by adapting its **policy** to this.

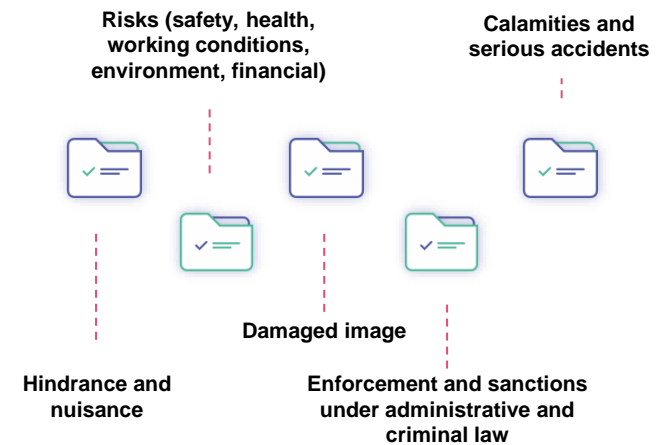
Effective use of available resources and smart investments contribute to **business continuity**.

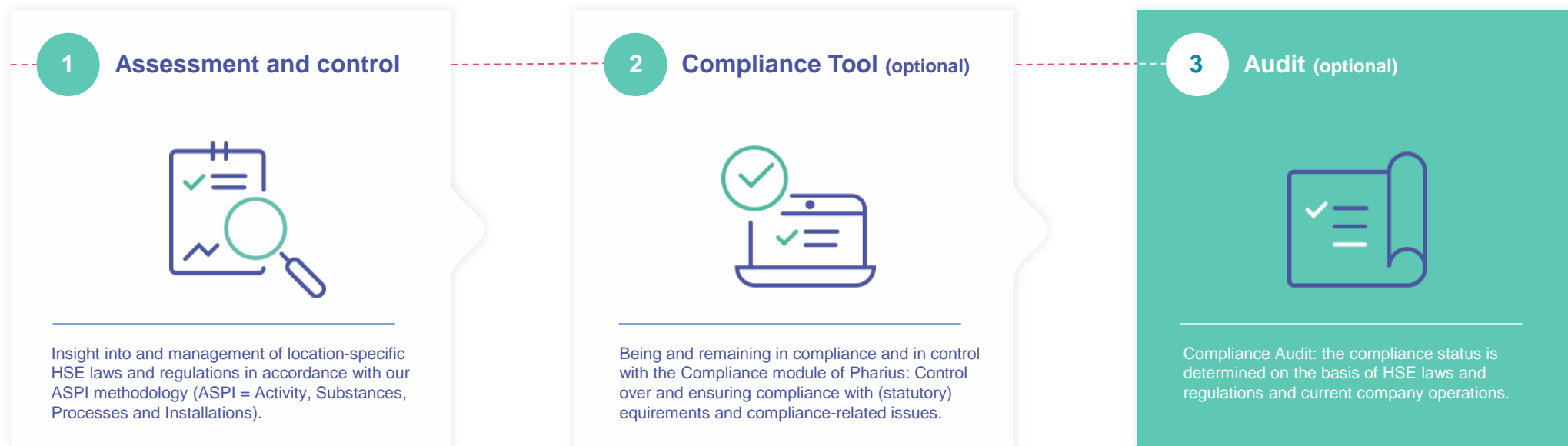


# Tailor-made compliance management

# Phase 1 | Assessment and control

## Insight into and control of location-specific HSE laws and regulations in accordance with our ASPI methodology

HSE laws and regulations are continually subject to change. In addition, company operations can **change**, as a result of which other laws and regulations are applied or applicable laws and regulations cease to be relevant. This is why we keep our customers fully informed about **relevant changes** by way of personal consultations, reporting and our Compliance Tool.

# Phase 2 | Compliance tool (optional)

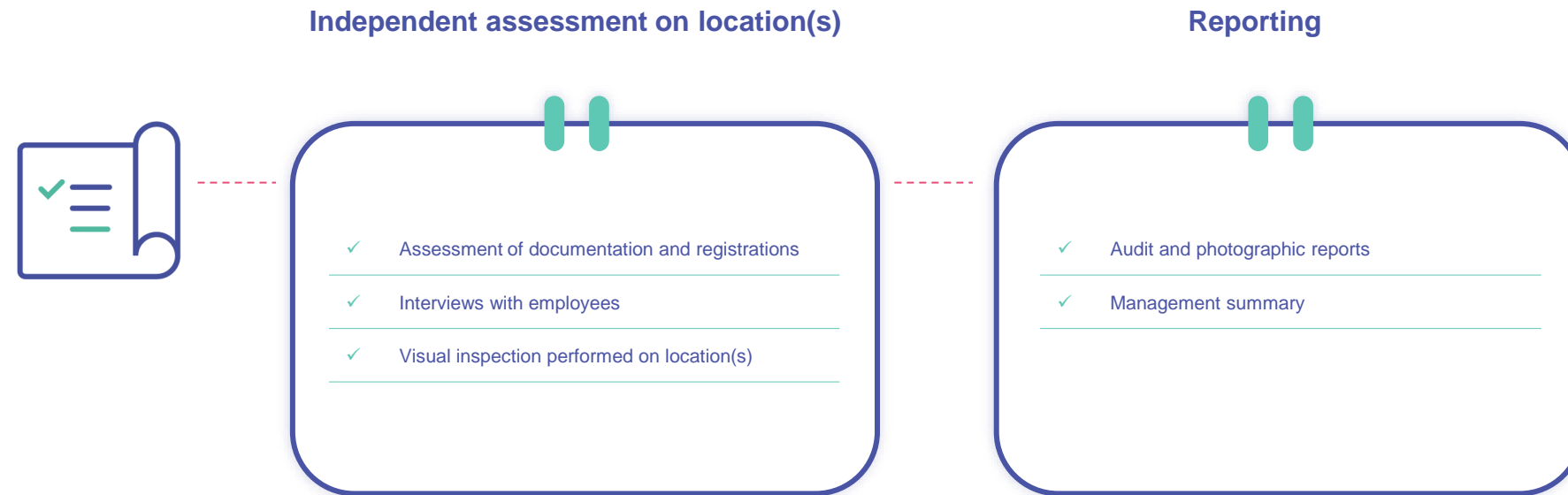
## Being and remaining in compliance and in control with the Compliance Tool: Control over and ensuring compliance with (statutory) requirements and compliance-related issues.

Optimal compliance management in one tool: The Compliance Tool provides permanent and comprehensive insight into laws and regulations and translates them into practical information for the organisation to use. The Compliance Tool creates insight for the organisation to understand relevant issues, to know its current status and to ascertain points for improvement, all of which can then be translated into concrete organisational measures. Control over and ensuring compliance with (statutory) requirements can lead to subsequent steps that affect Phase 1: assessment and control.



# Phase 3 | Audit (optional)

The compliance status of current company operations is assessed against the company-specific laws and regulations register.
